URGENT RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR DEFENSOR SR. GOVERNOR, PROVINCE OF ILOILO IN THE AMOUNT OF ONE MILLION PESOS (PHP1,000,000.00) AS LOCAL COUNTERPART OF THE MUNICIPALITY OF BINGAWAN FOR THE KALAHI-CIDSS: NCDDP OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD).

WHEREAS, the Local Government Unit of Bingawan pursues the objective of alleviating poverty incidence on the local level, which is in pursuance to one of the basic objectives of the National Community Driven Development Program;

WHEREAS, the Project aims to empower local communities through improved participation in local governance and involvement in the preparation and implementation of poverty reduction interventions;

WHEREAS, the Municipality of Bingawan is a recipient of KALAHI-CIDSS National Community-Driven Development Program for 3rd Cycle through the Department of Social Welfare and Development;

WHEREAS, the KALAHI-CIDSS:NCDDP 3rd cycle implementation is from June 2018 – August 2018;

WHEREAS, the Municipality agreed to provide the required cash and in-kind counterpart for the implementation of the program as included in the Capability Building Implementation Support (CBIS);
