**RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR R. DEFENSOR, JR., CONGRESSMAN, 3<sup>RD</sup> DISTRICT, PROVINCE OF ILOILO IN THE AMOUNT OF TWO MILLION PESOS (PHP2,000,000.00) FOR THE CONSTRUCTION OF THE MUNICIPAL SLAUGHTERHOUSE.**

**WHEREAS**, the local government of Bingawan was a recipient of a financial assistance from Senator Francis Escudero in the amount of Five Hundred Thousand Pesos (Php500,000) or the construction of Municipal Slaughterhouse situated at Bgry. Alabidhan, Bingawan, Iloilo;

**WHEREAS**, the said amount was insufficient to cover the construction cost which includes both materials and labor to finish the said slaughterhouse

**WHEREAS**, the Municipality of Bingawan is currently utilizing the old slaughterhouse situated at Brgy. Poblacion which is unsanitary due to rapid growth of population;

**WHEREAS**, this August body is requesting for financial assistance from Cong. Arthur R. Deforsnor, Jr. for the above-stated purpose;


