URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO AND LEMOS STORE, A SOLE PROPRIETORSHIP WITH OFFICE ADDRESS AT CATOERA STREET, POBLACION, BINGAWAN, ILOILO, HEREIN REPRESENTED BY JEANETTE A. LEMOS, PROPRIETOR, A MOA FOR THE ADVANCE PROCUREMENT OF RELIEF GOODS DURING THE OCCURRENCE OF A DISASTER/CALAMITY.

WHEREAS, The Local Government Unit is mandated by law to extend assistance to victims of disasters;

WHEREAS, the LGU's has a Five percent (5%) Municipal Disaster Risk Reduction Management Fund of the amount appropriated for MDRRMF, thirty percent (30%) of which shall be allocated as Quick Response Fund (QRF) or stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, complex emergencies, may be normalized as quickly as possible;

WHEREAS, the Lemos Store is an establishment that engaged in the business of grocery items and situated within the territorial jurisdiction of the LGU;

WHEREAS, the LGU cannot utilize their thirty percent (30%) MDRRM Fund before the occurrence of any disaster;

WHEREAS, by reason of the limitations provided in the use of the said fund, the LGU recognizes the need to make arrangements with local grocery store for the immediate preparation and stockpiling of supplies for use during disaster operations;

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian Concerned".

NOW THEREFORE:


ON MOTION of Hon. Leovy C. Simora, duly seconded by Hon. Jofe C. Celeste and Hon. Perceval T. Girao;

Lemos, Proprietor, a MOA for the advance procurement of relief goods during the occurrence of a disaster/calamity.


