**Resolution No. 49 - 2016**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO AND BINGAWAN GASOLINE STATION, A SOLE PROPRIETORSHIP WITH OFFICE ADDRESS AT CORNER CATALUÑA-CASTILLANES ST., POBLACION, BINGAWAN, ILOILO, HEREIN REPRESENTED BY MARCO H. DECENA, PROPRIETOR, A MOA FOR THE ADVANCE PROCUREMENT OF FUEL AND LUBRICANTS DURING THE OCCURRENCE OF A DISASTER/CALAMITY.**

**WHEREAS**, The Local Government Unit is mandated by law to respond during calamities/disasters;

**WHEREAS**, the LGU's has a Five percent (5%) Municipal Disaster Risk Reduction Management Fund of the amount appropriated for MDRRMF, thirty percent (30%) of which shall be allocated as Quick Response Fund (QRF) or stand-by fund for relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, complex emergencies, may be normalized as quickly as possible;

**WHEREAS**, the Bingawan Gasoline is an establishment that engaged in the business of fuel and oil lubricants items and situated within the territorial jurisdiction of the LGU;

**WHEREAS**, the LGU cannot utilize their thirty percent (30%) MDRRM Fund before the occurrence of any disaster;

**WHEREAS**, by reason of the limitations provided in the use of the said fund, the LGU recognizes the need to make arrangements with local gasoline station for the immediate preparation and stockpiling of fuel for use during disaster operations;

**WHEREAS**, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian Concerned".

**NOW THEREFORE:**

**ON MOTION** of Hon. Leovy C. Simora, duly seconded by Hon. Nemesio A. Cachite, Hon. Jose c. Rabago, Jr. and Hon. Eduardo A. Dalipe;

**RESOLVED** as it is hereby resolved, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo and Bingawan Gasoline Station, a sole proprietorship with Office Address at corner Cataluña-Castillanes St., Poblacion, Bingawan, Iloilo, herein represented by Marco H. Decena, Proprietor, a MOA for the advance procurement of fuel and lubricants during the occurrence of a disaster/calamity.
