GALLARES STREET, TAGBILARAN CITY, BOHOL HEREIN REPRESENTED BY MR. RON HAMILTON TAN, FOR THE FIREWORKS DISPLAY DURING THE FOUNDATION DAY AND PAGNAHI-AN FESTIVAL CELEBRATION.


