URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ILOILO REPRESENTED HEREIN BY HON. ARTHUR D. DEFENSOR, SR., GOVERNOR FOR THE IDENTIFICATION OF BENEFICIARIES, CONSTRUCTION AND COMMISSIONING OF BARANGAY SANITARY TOILETS IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, that the Province of Iloilo will launch the project “Sanitary Toilet for Toilet less Households in Iloilo Province-Batch 2;

WHEREAS, that the Province of Iloilo will designate the Provincial Health Office as chair of the committee and spearhead the implementation of the project and to identify the recipients;

WHEREAS, that the Province of Iloilo will provide (1) toilet bowl, 2 bags of cement and cash for work for every household recipient;

WHEREAS, the Municipality of Bingawan will receive 20 toilet bowls, 40 bags of cement and Php 6,500.00 pesos as cash for work;

WHEREAS, the Municipality thru their LGU team composed of the MSWDO, MHO and Barangay Officials shall identify recipients approved by the Mayor which shall then be validated by the Provincial Health Officer and shall conduct an orientation/meeting to household recipients what the Project is all about and what the Province of Iloilo expect from their co-partners;

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".

NOW THEREFORE:

ON MOTION of Hon. Perceval T. Girao; duly seconded by Hon. Joy L. Quimba and Hon. Lorens M. Belloga;

RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with the Provincial Government of Iloilo represented herein by Hon. Arthur D. Defensor, Sr., Governor for the identification of beneficiaries, construction and commissioning of Barangay Sanitary Toilets in the Municipality of Bingawan, Province of Iloilo.


