**URGENT RESOLUTION GRANTING OMNIBUS AUTHORITY TO HON. MARK P. PALABRICA, MUNICIPAL MAYOR, TO SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO ALL AGREEMENTS WITH THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY THE HON. ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO WITH REGARDS TO THE TRANSFER OF FUNDS RELATED TO THE PROJECTS AND ACTIVITIES OF THE PROVINCE TO THE MUNICIPALITY OF BINGAWAN FOR THE PERIOD OF JANUARY 2017 TO JUNE 30, 2019.**

**WHEREAS**, the municipality is a recipient of various projects from the Iloilo Provincial Government;

**WHEREAS**, the Iloilo Provincial Government has funds appropriated for the implementation of various programs and projects for infrastructure development, socio-cultural programs, purchase of equipment, facilities and/or goods for the Municipality of Bingawan, Iloilo;

**WHEREAS**, the said appropriated funds shall be transferred to the municipality for the purpose thereof;

**WHEREAS**, with respect to the signatory, the Municipal Mayor as Local Chief Executive shall represent the municipality in all contracts and agreements as provided under Section 444 (b) (1) (vi) (The Chief Executive: Powers, Duties, Function and Compensation) of the Local Government Code of 1991;

**NOW THEREFORE:**

**ON MOTION** of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite;

**BE IT RESOLVED**, as it is hereby resolved, to grant omnibus authority to Hon. Mark P. Palabrica, Municipal Mayor, to sign for and in behalf of the Municipality of Bingawan, Iloilo all agreements with the Iloilo Provincial Government represented by the Hon. Arthur D. Defensor, Sr., Governor, Province of Iloilo with regards to the transfer of funds related to the projects and activities of the Province to the Municipality of Bingawan for the period of January 2017 to June 30, 2019.
