**Resolution No. 58 - 2017**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO TO ENTER INTO AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY A CONTRACT OF EMPLOYMENT WITH MR. RAFFY C. DELA CRUZ, AN AMBULANCE DRIVER.**

**WHEREAS**, this Contract of Employment is being made and entered by and between the **MUNICIPALITY OF BINGAWAN**, a local government unit with office address at Pagara St., Poblacion, Bingawan, Iloilo herein represented by **HON. MARK P. PALABRICA**, Municipal Mayor, hereinafter referred to as **THE FIRST PARTY** and **MR. RAFFY C. DELA CRUZ**, an Ambulance Driver, hereinafter referred to as **THE SECOND PARTY**;

**WHEREAS**, the first Party now have two (2) units ambulance including the one donated by the Philippine Charity Sweepstakes Office (PCSO);

**WHEREAS**, the First Party is in need of an additional personnel to serve as Ambulance Driver;

**WHEREAS**, the Second Party has signified his intention to which the First Party has accepted, to provide the services needed by the latter;

**WHEREAS**, the Second Party possesses the qualification required of the job;

**WHEREAS**, the Second Party attest that he is not related within the fourth civil degree of consanguinity or affinity to the 1) hiring authority and or 2) representative of the First Party; that he has not been previously dismissed from the government service by the reason of an administrative offense; that he has not already reached the compulsory retirement age of Sixty-Five (65) years;

**WHEREAS**, the Second Party is hereby contracted as **AMBULANCE DRIVER** for the period of July 16, 2017 to December 31, 2017 in consideration of P160.00 rate per day to be paid on a bi-monthly basis chargeable to the General Fund of the First Party;

**WHEREAS**, the Second Party shall perform work at time and schedule agreed upon both parties, including Saturdays, Sundays and Holidays, if necessary;

**WHEREAS**, the Second Party is entitled of Compensatory Day-off or overtime pay pro rate to his daily wage as deemed appropriate, subject to recommendation/approval by his immediate supervisor;

**WHEREAS**, as Ambulance Driver, the Second Party is expected to perform the following functions, to wit:

- a) Drive the Ambulance of the Municipality to serve the needs of the constituents;
- b) Maintain the Ambulance and report any concern related thereto to the concerned personnel/official, and
- c) Perform such other functions as assigned by the contracting party.

**WHEREAS**, it is understood that this contract does not create an employer-employee relationship between the First Party and the Second Party, that the service rendered hereunder are not considered and will not be credited as government service; and that the latter is not entitled to benefits enjoyed by the regular employee of the First Party.

**NOW THEREFORE:**

**ON MOTION** of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Ted Peter P. Plagata;

**BE IT RESOLVED**, as it is hereby resolved, to authorize Hon. Mark P. Palabrica, Municipal Mayor of the Municipality of Bingawan, Province of Iloilo to enter into and sign for and in behalf of the municipality a Contract of Employment with Mr. Raffy C. Dela Cruz, an ambulance driver.
