PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF UNDERSTANDING WITH DEPARTMENT OF LABOR AND EMPLOYMENT REGION 6 REPRESENTED BY JOHNSON G CAÑETE , DIRECTOR, FOR THE GOVERNMENT INTERNSHIP PROGRAM (GIP) PARTNER/EMPLOYER.

WHEREAS, the DOLE through Regional Office 6 the GIP Partner/Employer have agreed to enter into an understanding for the purpose of achieving the goals of the Government Internship Program of the DOLE, that is, to provide opportunities and engage young workers to serve the general public in government agencies/entities at the national and local level;

WHEREAS, the DOLE through Regional Office 6, as the implementer of the GIP undertakes to provide and assign the interns-beneficiaries to the GIP Partner/Employer's office to perform tasks and duties within those prescribed under Administrative Order No. 39-A, series of 2014, Administrative Order No. 260, series of 2015 and Administrative Order No. 67, series of 2016;

WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".
