Resolution No. 67 - 2017

RESOLUTION ENJOINING ALL BARANGAY OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO TO CREATE THE BARANGAY SCHOOL BOARDS AND BARANGAY HEALTH BOARDS

WHEREAS, Section 391 of RA 7160 otherwise known as the Local Government Code of 1991 states that "the SangguniangBarangay, as the legislative body of the barangay shall:

(1) Enact ordinances as may be necessary to discharge the responsibilities conferred upon it by law or ordinance and to promote the general welfare of the inhabitants therein;

(17) Organize regular lectures, programs or fora on community problems such as sanitation, nutrition, literacy, and drug abuse, and convene assemblies to encourage citizen participation in government;

(19) Provide for the proper development and welfare of children in the barangay by promoting and supporting activities for the protection and total development of children, particularly those below seven (7) years of age;

(20) Adopt measures towards the prevention and eradication of drug abuse, child abuse, and juvenile delinquency;

(21) Initiate establishment of a barangay high school, whenever feasible, in accordance with law;

(22) Provide for the establishment of a non - formal education center in the barangay whenever feasible, in coordination of Education, Culture and Sports;

(23) Provide delivery of basic services; and

(24) Exercise such other powers and perform such other duties and functions as may be prescribed by law or ordinance;

WHEREAS, Sections 98 and 102 of the said Code provides for the creation of the Local School Boards and Local Health Boards, respectively in every province, city or municipality;

WHEREAS, there is a need to create a school board and health board in every barangay in order to strengthen and respond to the education and health concerns of the municipality which require the help of the barangays;

ON MOTION of, Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite and Hon. Perceval T. Girao;

RESOLVED, as it is hereby resolved, to enjoin all barangay of the Municipality of Bingawan, Province of Iloilo to create the Barangay School Boards and Barangay Health Boards;


RESOLVED FURTHER, that an Ordinance be passed by all Barangay Councils for the creation of Barangay School Boards and Barangay Health Boards;


