URGENT RESOLUTION ADOPTING THE ZERO OPEN DEFECATION PROGRAM (ZODP) OF THE DEPARTMENT OF HEALTH (DOH) FOR ALL BARANGAYS AND TASKING THE BINGAWAN RURAL HEALTH UNIT TO HELP IMPLEMENT THIS HEALTH PROGRAM.

WHEREAS, RA 7160 otherwise known as the Local Government Code of 1991, provides that local government units with their respective territorial jurisdiction to ensure the general welfare particularly on safety, social justice, and preservation of comfort and convenience of its constituents to be one of their optimum priority;

WHEREAS, the National Sustainable Sanitation Plan, approved May 10, 2010 provides a process of empowering families to partner with Local Government Unit and other stakeholders to address sanitation issues and problem using affordable, appropriate and dynamic sanitation technologies supported by legal/regulatory framework;

WHEREAS, Open Defecation is an unsanitary practice of defecating in areas not designated as toilet, like in the rivers, fields, parks and open trenches that may lead to public health problems like diarrhea, under nutrition, parasitism, cholera, typhoid, hepatitis and many others;

WHEREAS, the Municipality of Bingawan was declared by the Department of Health on March 7, 2016 as Zero Open Defecation;

WHEREAS, the RHU of Bingawan was tasked to help implement this DOH health program and to craft its implementing guidelines and use local strategies and technical knowledge;

WHEREAS, the barangay councils shall sustain the campaign with the technical supervision of the RHU personnel. Each Barangay is encouraged to sustain the Zero Open Defecation status;

NOW, THEREFORE:

ON MOTION of Hon. Levy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite, Hon. Perceval T. Girao, Hon. Ted Peter P. Plagata. and Hon. Jose C. Rabago, Jr.;

BE IT RESOLVED, as it is hereby resolved, to adopt the Zero Open Defecation Program (ZODP) of the Department of Health (DOH) for all barangays and tasking the Bingawan Rural Health Unit to help implement this health program.
