**Resolution No. 79 - 2017**

**URGENT RESOLUTION ADOPTING THE MDC RESOLUTION NO. 5, SERIES OF 2017 APPROVING THE 20% IRA DEVELOPMENT FUND FOR CALENDAR YEAR 2018 OF THE MUNICIPALITY OF BINGAWAN, ILOILO.**

**WHREAS**, pursuant to Section 106 (par a) of R. A. 7160 otherwise known as the Local Government Code of 1991 each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the municipal or barangay level shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

**WHREAS**, pursuant to Section 114 (par a) of R. A. 7160 the policies, programs and projects proposed by local development councils shall be submitted to the sanggunian concerned for appropriate action;




