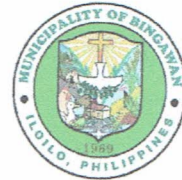

URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE PROVINCIAL GOVERNMENT OF ILOILO REPRESENTED HEREIN BY HON. ARTHUR D. DEFENSOR, SR., GOVERNOR FOR THE DISTRIBUTION AND INSTALLATION OF JETMATIC HAND PUMPS TO EL NIÑO AFFECTED BARANGAYS IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, El Niño is a natural phenomenon which is characterized by unusually warm ocean surface temperatures in the central and eastern equatorial Pacific (CEEP) which have devastating implication on our country including economic, social, health related problems that could be detrimental to the well-being of the country and of the people;

WHEREAS, to date, the Municipality of Bingawan, is one of the seven (7) municipalities in the Province of Iloilo that was placed under the State of Calamity because of the effects of El Niño;

WHEREAS, in order to mitigate the adverse effects of El Niño, the Iloilo Provincial Government has constituted an El Niño Task Force to plan out and formulate strategies and initiatives designed to absorb its effects;

WHEREAS, one of the strategies of the Provincial Government of Iloilo is to distribute and install Jetmatic Hand Pump Set to El Niño affected barangays in the Province of Iloilo as a means of providing the badly needed water to household beneficiaries;

WHREAS, a Memorandum of Agreement is necessary to ensure the proper use of the Hand Pump Set and to lengthen the life span of the system as well as for accountability purposes;


WHEREAS, Section 22 (c) of RA 7160 provides that "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned".

NOW THEREFORE:


