RESOLUTION TO CHANGE THE TITLE OF THE PROGRAM UNDER THE DISASTER PREPAREDNESS OF THE LOCAL DISASTER RISK REDUCTION AND MANAGEMENT PROGRAM CY 2016 "REPAIR/MAINTENANCE OF OTHER PUBLIC STRUCTURE AND EQUIPMENT" TO "REHABILITATION/IMPROVEMENT OF EVACUATION CENTER AND EQUIPMENT"

WHEREAS, Resolution No. 15-2017 of the Sangguniang Bayan adopted the Municipal Disaster Risk Reduction and Management Council's Resolution No. 1, s. 2017, approving and adopting the reprogramming of the 2016 remaining balance of the programs, projects and activities of the Local Disaster Risk Reduction and Management Fund in the amount of One Million Three Hundred Fifty Nine Thousand Five Hundred Sixty Nine Pesos and Two Centavos (P1,359,569.02) as approved by the Municipal Disaster Risk Reduction and Management Council;

WHEREAS, there were programs, projects and activities in the 2016 LDRRM Fund that was not utilized during the said Calendar Year leaving a remaining balance in the amount of One Million Three Hundred Fifty Nine Thousand Five Hundred Sixty Nine Pesos and Two Centavos (P1,359,569.02);

WHEREAS, the MDRRMC unanimously agreed to reprogram the identified and prioritized programs, projects and activities included in the LDRRM Fund CY 2016 to LDRRMF 2017;

WHEREAS, the Municipality would like to utilize the budget from the Repair and Maintenance of other Public Structures and Equipment to procure a Transformer for the use of the Evacuation Center/Municipal Covered Gym;

WHEREAS, in order to release the budget, the name of the project "Repair and Maintenance of other Public Structures and Equipment" under the Disaster Preparedness of the LDRRM Fund need to be changed to "Rehabilitation/Improvement of Evacuation Center and Equipment" to conform to the guidelines of the Commission of Audit (COA);




