
**WHEREAS**, the Council formulated the Contingency Plan for Typhoon and Flood CY 2017-2018 for the said situations;

**ON MOTION** of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Perceval T. Girao.


