**WHEREAS**, the Local Government Unit of Bingawan pursues the objective of alleviating poverty incidence on the local level, which is in pursuance to one of the basic objectives Millennium Development Goals;

**WHEREAS**, the KALAHY-CIDSS Project aims to empower local communities through improved participation in local governance and involvement in the preparation and implementation of poverty reduction interventions;

**WHEREAS**, local government unit of Bingawan is already practicing people's participation, transparency and accountability (PTA) through "Pamangkutanon sa Banwa" program pursuant to municipal ordinance no. 01 series of 2004 dated October 20, 2004 prior to the implementation of KALAHY-CIDSS project in the year 2008 in this municipality;

**NOW THEREFORE:**


**ON MOTION** of Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Perceval T. Girao.
