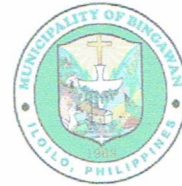

**RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL RESOLUTION NO. 4, SERIES OF 2017, "APPROVING VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES TO BE INCLUDED IN THE COMPREHENSIVE DEVELOPMENT PLAN FOR CALENDAR YEAR 2017-2019 OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO".**

**WHEREAS**, presented to for consideration of the August Body is Municipal Development Council Resolution No. 1, Series of 2017, in deference to Section 106, of R. A. 7160, otherwise known as the Local Government Code of 1991, that "(a) each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its Sanggunian. For this purpose, the development council at the municipal level, shall assist the corresponding Sanggunian in setting the direction of the economic and social development, and coordinating development efforts within its territorial jurisdiction";

**WHEREAS**, pursuant to Section 114 of the said Code, (a) "the policies, programs and projects proposed by the local development council shall be submitted to the sanggunian for appropriate action";

**WHEREAS**, after a thorough deliberation of the concerned committee and by the August Body, the approved various Programs, Projects and Activities to be included in the Comprehensive Development Plan for Calendar Year 2017-2019 of the Municipality of Bingawan, Province of Iloilo, are found to be consonant with the currents of the municipality;
