**MUNICIPAL ORDINANCE NO. 261  
 (Series of 2018)**

**AN URGENT ORDINANCE TEMPORARILY CLOSING PORTION OF CATOERA ST., BRGY. POBLACION, BINGAWAN, ILOILO DURING THE 2018 ILOILO PROVINCIAL COOPERATIVE MONTH CELEBRATION ON OCTOBER 9-25, 2018.**

**WHEREAS**, the Municipality of Bingawan is hosting the 2018 Iloilo Provincial Cooperative Month Celebration on October 9-25, 2018;

**WHEREAS**, pursuant to Section 21 of R.A. 7160, otherwise known as the local government code of 1991, a local government unit may, pursuant to an ordinance, temporarily close any road; the duration of which shall be specified by the local chief executive in a written order; and an adequate route shall be provided ;

**NOW, THEREFORE:**

**ON MOTION** of Hon. Ted Peter P. Plagata, seconded by Hon. Jose C. Rabago, Jr.;

**BE IT ORDAINED** by the Sangguniang Bayan assembled that:

Section 1. Closure of street. The following street is hereby temporarily closed:

- a. Catoera Street (beside SK Hall and Poblacion Barangay Hall only) – Food Festival Site

Commercial vehicles, except those hired by guests, visitors and residents with vehicles in the area, are hereby prohibited to ply the above cited areas as they are primarily intended for parking area for guests/visitors and food festival site. Rerouting of traffic and parking arrangement should be at the sound discretion of the authorities concerned - the local PNP and the Traffic Management Group.

Section 2. Duration. The temporary closure of the above-cited streets shall be lifted automatically after said celebration.

Section 3. Effectivity. This ordinance shall take effect on the dates above cited.


