PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A SPECIFIC IMPLEMENTATION AGREEMENT WITH DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)- FIELD OFFICE VI WITH OFFICE ADDRESS AT M.H. DEL PILAR STREET, MOLO, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE SUSTAINABLE LIVELIHOOD PROGRAM (SLP).

Presented for consideration of the August Body is Committee Report No. 03-2018 of the Committee on Women, Family Affairs and Social Welfare, relative to the granting of authority to the local chief executive to enter an agreement with DSWD for the implementation of Sustainable Livelihood Program (SLP);

WHEREAS, the Committee Report favourably recommends the passage of said resolution as the Sustainable Livelihood Program will address the needs of the poor in the community and in deference to Section 16 (General Welfare) of R.A. 7160;

WHEREAS, Section 22 (c) of the above-cited code further provides, that “no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall;

On motion of Hon. Joy L. Quimba, duly seconded by Hon. Nemesio A. Cachite;


