DEL PILAR STREET, MOLO, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE PANTAWID PAMILYANG PILIPNO PROGRAM.**

Presented for consideration of the August Body is Committee Report No. 03-2018 of the Committee on Women, Family Affairs and Social Welfare, relative to the granting of authority to the al chief executive to enter into a Specific Implementation Agreement for thePantawid Pamilyang Pilipino Program (4Ps);

**WHEREAS**, the Pantawid Pamilyang Pilipino Program aims to extend assistance to extremely poor households in the community through various programs and services to improve their living conditions;

**WHEREAS**, the Committee Report favourably recommends the passage of said resolution as the Pantawid Pamilyang Pilipino Program (4Ps) will address the needs of the poor in the community and in deference to Section 16 (General Welfare) of R.A. 7160;

**WHEREAS**, Section 22 (c) of the above-cited code further provides, that “no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall;


