Resolution No. 114 – 2018

RESOLUTION URGING ALL BARANGAYS TO INTENSIFY THE IMPLEMENTATION OF THE 4S STRATEGY AS A PREVENTIVE MEASURE FOR DENGUE IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO

WHEREAS, dengue is a viral disease with *Aegis egypti* and *Aedesalbopictus* mosquitoes as vectors (carriers). It has serious complications such as bleeding, low level of blood platelets and dangerously low blood pressure that can result to death;

WHEREAS, in its drive to prevent the spread of dengue disease in communities, the Department of Health (DOH) has pushed for the practice of the 4s strategy: searching and destroying mosquito breeding places; securing self-protection; seeking early consultation; and supporting fogging and spraying in hotspot places;

WHEREAS, there are dengue cases in the Municipality of Bingawan and it calls for urgent measures to avert the high incidence of dengue in the municipality;

NOW THEREFORE:

On motion of Hon. Ted Peter P. Plagata, Floor Leader, duly seconded by Hon. Nemesio A. Cachite;

RESOLVED AS IT IS HEREBY RESOLVED, to urging all barangays to intensify the implementation of the 4S strategy as a preventive measure for dengue in the municipality of Bingawan, Province of Iloilo.


