**AN ORDER REORGANIZING THE MUNICIPAL INTER-AGENCY COMMITTEE (MIAC) OF THE MUNICIPALITY OF BINGAWAN, ILOILO**

**WHEREAS**, the DSWD envisaged empowering the poor, disadvantage, and vulnerable groups for them to have quality of life and and implement this project to fulfill such vision;

**WHEREAS**, the project aims to empower local communities through improved participation in local governance and involvement in the preparation and implementation of poverty reduction and interventions;

**WHEREAS**, the project is jointly funded, among others, grant from the World Bank and the government of the Republic of the Philippines intended as Seed Capital for Community Development sub-projects;

**WHEREAS**, the municipality and all her barangays has been selected as one of the project beneficiaries of the Kalahi- CIDSS: Direct Funding

**WHEREAS**, there is a need to reorganize the Municipal Inter- Agency Committee (MIAC) of the municipality of Bingawan, Iloilo;

**NOW, THEREFORE**, I, MARK P. PALABRICA, Municipal Mayor, by virtue of the power vested in me by law, do hereby reorganize the Municipal Inter- Agency Committee (MIAC) of Bingawan, Iloilo:

**Section 2: FUNCTIONS:** The MIAC members shall exercise the following duties and powers, to wit:

- 1.) Coordinate all concerns/requirements with the various national government agencies, non-government organization and basic sectors/ organization in the implementation, monitoring and evaluation of CIDSS implementation;
- 2.) Review and resolve issues/concerns relative to the CIDSS implementation;
- 3.) Monitor and evaluate the implementation of the various commitments of partner agencies;
- 4.) Submit regular status report and policy recommendation in the implementation of CIDSS commitments and all related policies to the national Screening Committee.
- 5.) MIAC members will be divided into committees as follows: Grievance Redress System; O&M monitoring and evaluation; finance; project monitoring; and documentation committee for easier provision of technical assistance to the barangays.
