**EXECUTIVE ORDER NO. 30**

**AN ORDER RE-ORGANIZING THE MUNICIPAL LOCAL DEVELOPMENT COUNCIL (MDC) FOR THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO**

**WHEREAS**, pursuant to Section 106 of RA 7160 otherwise known as the Local Government Code of 1991, provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by the development council and approved by its Sanggunian;

**WHEREAS**, under the same section of the aforesaid Republic Act, it further provide that the Local Development Council at the municipal level shall assist the corresponding Sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction accredited per Sanggunian Bayan Resolution No. 59-2013 dated September 4, 2013;

**WHEREAS**, Section 107 of the Local Government Code of 1991 provides and defines for the composition of Local Development Council at the municipal level with involvement and participation of the civil society organizations or non-government organizations that are existing in its territorial jurisdiction;

**WHEREAS**, DBM-DILG-DSWD-NAPC Joint Memorandum Circular No. 4, dated November 26, 2013, paragraph 4.6 provides that the municipalities that have graduated from or currently implementing the KALAHI-CIDSS Program shall undergo the Enhanced Grassroots Budgeting Process, wherein the LPRAT shall perform its functions as the technical working group of the Enhanced Local Development Council (LDC);

**WHEREAS**, under the paragraph 4.7 of the aforesaid Joint Memorandum Circular, the Enhanced Local Development Council (LDC) refers to the Local Development Council (LDP) with an expanded membership to include the regular members of the LDC with the addition of all 6 Vice-Chairs of the Barangay Development Councils who are to be elected from among the KALAHI-CIDSS community volunteers and all Local Government Department Heads shall be invited to sit as observers and resource persons in the Enhanced LDC.

**WHEREAS**, new members are sitting in the council as a result of the barangay elections and OSCA elections last May 14, 2018 and April 29, 2018 respectively;

**NOW, THEREFORE, I, MARK P. PALABRICA**, Local Chief Executive of the Municipality of Bingawan, Province of Iloilo, by virtue of the powers vested in me, do hereby re-organized and mobilize the Municipal Development Council of the Municipality of Bingawan, Iloilo to wit:

**Section I. Composition.** The Municipal Development Council shall be composed of the following:

**Section II. Function.** The Municipal Development Council shall have the following functions:

1. Formulate long-term, medium-term and annual socio-economic development plans and policies;
2. Formulate the medium-term and annual public investment programs;
3. Appraise and prioritize socio-economic development programs and projects;
4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
5. Coordinate, monitor and evaluate the implementation of development programs and projects;  
and
6. Perform such other functions as may be provided by law or competent authority

**Section III. Meeting and Quorum.** The Municipal Development Council shall meet once every quarter or often as maybe necessary.

**Section IV. Executive Committee.** The Executive Committee is hereby created to represent the Municipal Development Council and act in its behalf if it is not in session. The composition of the executive committee shall be as follows:

The executive committee shall exercise the following powers & functions:

1. Ensure that the decision of the council are faithfully carried out and implemented;
2. Act on matters requiring immediate attention or action by the council;
3. Formulate policies, plans and programs based on the general principles laid down by the council; and
4. Act on other matters that may be authorized by the council.


