AN ORDER CREATING THE MUNICIPAL BLOOD PROGRAM COUNCIL TO PROMOTE VOLUNTARY BLOOD DONATION IN THE MUNICIPALITY OF BINGAWAN.

WHEREAS, Republic Act 7719 otherwise known as the “ National Blood Services Act of 1994” was passed to ensure safe and efficient Blood Banking and transfusion practices in the Philippines promotes voluntary blood donation, providing for and adequate supply of safe blood, regulating blood banks and provides penalties for violation thereof;

WHEREAS, Republic Act 10072 otherwise known as the “ Philippine Red Cross Act of 2009” recognizes the Philippine National Red Cross as an independent autonomous, nongovernmental organization auxiliary to the authorities of the Republic of the Philippines in the humanitarian field, to be known as the Philippine Red Cross;

WHEREAS, the Philippines is a disaster risk area prone to typhoons, earthquake and other calamities brought by climate change that needs preparedness;

WHEREAS, there shall be a Municipal Blood Program Council to promote voluntary blood donation in the Municipality in order to ensure adequate supply of blood when the needs arises;

WHEREAS, there is a need to reach the target output of 1% of the population of the Municipality;

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Iloilo, by virtue of the powers vested on me by law, do hereby order the following:

SECTION 1. Creation and Composition. The Municipal Blood Program Council shall be composed of the following:

Section 2. Duties and Functions. The Municipal Blood Program Council shall have the following duties and functions:

- a. Designation of Volunteer Blood Coordinator;
- b. Shall meet at least every quarter;
- c. Promote and encourage voluntary blood donation;
- d. Prepare programs and activities for the promotion of voluntary blood donation;
- e. Schedule bloodletting at least twice a year;
- f. Ensure that there will be voluntary blood donors during bloodletting activities;
- g. Come up with a Blood Registry that provides for a list of qualified voluntary blood donors with their specific blood typing.

Section 3. Effectivity. This Executive Order shall take effect immediately.
