EXECUTIVE ORDER NO. 41
Series of 2018

AN ORDER DESIGNATING THE ANTI-DRUG ABUSE COUNCIL-REPORTING SYSTEM (ADAC-RS) TEAM.

WHEREAS, Section 16 of Republic Act RA (7160), otherwise known as the Local Government Code of 1991 mandates that Local Government Unit (LGUs) shall, within their territorial jurisdictions, promote health and safety, improve public morals, maintain peace and order and preserve the comfort and convenience of the people;

WHEREAS, the Department of the Interior and Local Government (DILG)-Dangerous Drugs Board (DDB) issued Joint Memorandum Circular No. 2018-01 date May 21, 2018 that mandates for the designation of two (2) ADAC-RS Focal Persons. Preferably plantilla positions who are members of the Municipal ADAC and two (2) encoders;

WHEREAS, the proliferation and used of illegal drugs hinder the overall efforts aimed at promoting community peace and harmony and meaningful local development;

WHEREAS, the designation of ADAC-RS team is imperative to assist the MADAC to have an effective monitoring and reporting mechanism;

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Iloilo, by virtue of the powers vested in me by law, do hereby designate personnel as ADAC-RS Focal Persons and Encoders, to wit:

SECTION 1. COMPOSITION OF ADAC-RS TEAM



Section 2. Duties and Functions

1. Encode the necessary information on Person Who Use drugs (PWUD) who surrendered in accordance with the Community-Based Treatment and rehabilitation Monitoring Form,
2. Ensure monthly submission of reports;
3. Ensure the accuracy and confidentiality of data;
4. Ensure that data of all PWUD who surrendered to authorities be encoded in the system,
5. In case there is no person who surrendered for the month, report the same to the DDB through email;
6. Report problems encountered in the ADAC-RS by filing out the Issue Report Form.

Section 3. Effectivity. This Executive Order shall take effect immediately
