AN ORDER DESIGNATING HON. JOY L. QUIMBA, SB MEMBER AS OFFICER-IN-CHARGE (OIC) OF THE OFFICE OF THE MUNICIPAL MAYOR OF THE MUNICIPALITY OF BINGAWAN, ILOILO ON NOVEMBER 6 UNTIL NOVEMBER 8, 2018 WHILE THE MUNICIPAL MAYOR, HONORABLE MARK P. PALABRICA IS ON OFFICIAL TRAVEL TO METRO MANILA TO ATTEND THE 2018 SGLG NATIONAL AWARDING CEREMONY AND FOLLOW-UP VARIOUS PROJECTS OF THE MUNICIPALITY OF BINGAWAN.

WHEREAS, Section 46 (c) of Republic Act 7160 otherwise known as the Local Government Code of 1991 states that " when the incumbent local chief executive is traveling within the country but outside his territorial jurisdiction for a period not exceeding three(3) consecutive days, he may designate in writing the officer-in-charge of the said office. Such authorization shall specify the powers and functions that the local official concerned shall exercise in the absence of the local chief executive except the power to appoint, suspend, or dismiss employees";

WHEREAS, the Municipal Mayor is on official travel to Metro Manila for three (3) days to attend the 2018 SGLG National Awarding Ceremony and follow-up various projects of the Municipality of Bingawan;

NOW THEREFORE, I, MARK P. PALABRICA, Municipal Mayor of the Municipality of Bingawan, Province of Iloilo, by virtue of the powers vested in me by law, do hereby order, that;

Section 1. Hon. Joy L. Quimba, SB Member is hereby designated as Officer-In-Charge (OIC) of the Office of the Municipal Mayor of the Municipality of Bingawan, on November 6 until November 8, 2018 while the Municipal Mayor, Honorable Mark P. Palabrica is on official travel to Metro Manila to attend the 2018 SGLG National Awarding Ceremony and follow-up various projects of the Municipality of Bingawan;

Section 2. The OIC-Mayor shall automatically exercise the powers and perform the duties and functions of the local chief executive concerned, except the power to appoint, suspend, dismiss employees.

Section 3. This Executive Order shall take effect immediately on the date above stated.
