**EXECUTIVE ORDER NO. 61**

**AN ORDER TO AUGMENT FUND FROM TRAVELLING EXPENSES TO TRAINING AND SEMINAR EXPENSES IN THE AMOUNT OF NINE THOUSAND THREE HUNDRED PESOS ONLY (9,300.00) UNDER THE OFFICE OF THE MUNICIPAL ASSESSOR.**

**WHEREAS**, Section 336 of RA 7160, otherwise known as “Local Government Code of 1991”, provides that the “Local Chief Executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved of annual budget for their respective offices from savings in the other items within the same class of their respective appropriations”;

**WHEREAS**, pursuant to Section 6 of Appropriation Ordinance No. 247, Series of 2017 of the Municipality of Bingawan dated December 13, 2017, states that “the Local Chief Executive of the Municipality and the Municipal Vice Mayor as the Presiding Officer of the Sangguniang Bayan are hereby authorized to augment any item in this Annual Budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

**WHEREAS**, pursuant to accounting rules, laws and procedure, funds can be transferred, provided they belong to the same category;

**WHEREAS**, from travelling expenses to training and seminar expenses belong to the same expense class and category;

**WHEREAS**, the Office of the Municipal Assessor needs to allocate fund from travelling expenses to training and seminar expenses;

**WHEREAS**, the above- mentioned transfer of funds belong to the same expense class and category.


**NOW THEREFORE, I, MARK P. PALABRICA**, Municipal Mayor of the Municipality of Bingawan, Iloilo, by virtue of the powers vested on me by law, do hereby order that;

**SECTION 1.** The fund from travelling expenses to training and seminar expenses of the Office of the Municipal Assessor in the amount of Nine Thousand Three Hundred Pesos Only (9,300.00) is hereby augmented.

**SECTION 2.** This Executive Order shall take effect immediately.
