**AN ORDER TO AUGMENT FUND FROM BAC TRAINING TO SEMINARS AND TRAININGS IN THE AMOUNT OF TEN THOUSAND PESOS ONLY (Php10,000), FROM REPAIR OF OFFICE EQUIPMENT TO SEMINARS AND TRAININGS IN THE AMOUNT OF TEN THOUSAND PESOS ONLY (Php10,000.00), FROM OTHER MAINTENANCE AND OPERATING EXPENSES (MOOE) TO SEMINARS AND TRAININGS IN THE AMOUNT OF TEN THOUSAND PESOS (Php10,000.00) AND REPAIR/MAINTENANCE OF TRANSPORTATION TO TRAVELLING EXPENSES IN THE AMOUNT OF FOUR THOUSAND PESOS ONLY (Php4,000.00) UNDER THE OFFICE OF THE MUNICIPAL SOCIAL WELFARE AND DEVELOPMENT.**

**WHEREAS**, Section 336 of RA 7160, otherwise known as “Local Government Code of 1991”, provides that the “Local Chief Executive or the presiding officer of the sanggunian concerned may, by ordinance, be authorized to augment any item in the approved of annual budget for their respective offices from savings in the other items within the same class of their respective appropriations”;

**WHEREAS**, pursuant to Section 6 of Appropriation Ordinance No. 247, Series of 2017 of the Municipality of Bingawan dated December 13, 2017, states that “the Local Chief Executive of the Municipality and the Municipal Vice Mayor as the Presiding Officer of the Sangguniang Bayan are hereby authorized to augment any item in this Annual Budget for their respective offices from savings in other items within the same expense class of their respective appropriations;

**WHEREAS**, pursuant to accounting rules, laws and procedure, funds can be transferred, provided they belong to the same category;

**WHEREAS**, from BAC training to seminars and trainings, from repair of office equipment to seminars and trainings, to other maintenance and operating expenses to seminars and trainings and from repair/maintenance of transportation to travelling expenses belong to the same expense class and category;

**WHEREAS**, the Office of the Municipal Social Welfare and Development needs to allocate fund from BAC training to seminars and trainings, from repair of office equipment to seminars and trainings, from other maintenance and operating expenses (MOOE) and from repair/ maintenance of transportation to travelling expenses;

**WHEREAS**, the above- mentioned transfer of funds belong to the same expense class and category.

**NOW THEREFORE, I, MARK P. PALABRICA**, Municipal Mayor of the Municipality of Bingawan, Iloilo, by virtue of the powers vested on me by law, do hereby order that;

**SECTION 1.** The funds for the expenses are hereby augment, to wit:
