**AN ORDER REORGANIZING THE MUNICIPAL PRICE COORDINATING COUNCIL
IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.**

WHEREAS, pursuant to R.A. 7581 otherwise known as the "Price Act" that provides protection to consumer's by stabilizing the prices of basic necessities and prime commodities and by prescribing measures against undue price increases during emergency situations and like occasions ;

WHEREAS, it is the policy of the state that the availability of basic necessities and price commodities at reasonable prices at all times without denying legitimate business is a fair return on investment;

WHEREAS, it is also a declared policy of the state to provide effective and sufficient protection to consumers against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing on said goods, especially during periods of calamity, emergency, widespread illegal price manipulation and other similar situations;

NOW, THEREFORE, I, MARK P. PALABRICA, Municipal Mayor and Local Chief Executive of the Municipality of Bingawan, Iloilo by virtue of powers vested in me by law, do hereby re-organize the Municipal Price Coordinating Council and hereby establish its composition, powers and functions.

1. Price Coordinating Council- there is hereby re-organize Price Coordinating Council, hereafter referred to as council, to be composed of the following members:

2. Functions of the Price Coordinating Council- The Price Coordinating Council shall have the following functions:


1. It shall coordinate the productivity distribution and price stabilization programs, projects and measures of Local Government and develop comprehensive strategies to affect general stabilization of prices of basic necessities and price commodities at affordable levels;
2. It shall report to the Municipal Mayor and Sanggunian the status and progress of the programs, projects and measures undertaken by national agencies and offices;
3. Create committee which shall advise local health agencies on matters of personnel selection and promotion, bids and awards, grievance and complaints, personnel discipline, budget review, operations review and similar functions;
4. Conduct meeting at least once a month or as necessary, and conduct public hearings for purposes of assessing the supply distribution and price situation of any basic necessity and prime commodity, and publicize its results and development; and
5. Whenever automatic price control is being imposed under Sec. 6. R.A. 7581, it shall disseminate prevailing prices or the price ceiling within the locality.

3. Repealing Clause- Any part of this order which is inconsistent to the provision of existing law is hereby repealed and modified accordingly.

4. Effectivity. This Executive Order shall take effect immediately.
