**Resolution No. 101 - 2018**

**URGENT RESOLUTION AUTHORIZING LANDBANK OF THE PHILIPPINES TO DEBIT THE ACCOUNT UPON INSTRUCTION FROM THE PAYMENT APPLICATION SECURE SYSTEM 5 (PASS 5) ON BEHALF OF THE MUNICIPALITY OF BINGAWAN, IN ORDER TO EFFECT OUR TAXES AND DUTIES PAYMENT IMPOSED BY THE BUREAU OF CUSTOMS.**

**WHEREAS**, the Municipality of Bingawan has expressed intention to apply for Payment Application Secure System 5 (PASS 5) enrolment under Account Name: Municipality of Bingawan and Account Number 0032-1929-12;

**WHEREAS**, the aforementioned application is to effect payment for taxes and duties imposed by the Bureau of Customs for importation;

**WHEREAS**, that the Sangguniang Bayan of Bingawan, Iloilo has authorized Hon. Mark Palabrica, Municipal Mayor and Mrs. Amalia Pamocol, Municipal Treasurer as signatories to the newly opened account of the municipality with LBP Iloilo City Branch as per Sangguniang Bayan Resolution No. 44 -2018 ;

**NOW THEREFORE;**

**On motion of** Hon. Ted P. Plagata, Floor Leader, duly seconded by Hon. Ramil P. Artuz;

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Land Bank of the Philippines to debit the Account upon the instruction from the PASS 5, on behalf of the Municipality of Bingawan, in order to effect our taxes and duties payment imposed by the Bureau of Customs;


**RESOLVED FURTHER**, that ALL withdrawals should be signed by the above-mentioned signatories;
