LOSBAÑES, OFFICER-IN-CHARGE FOR WORK IMMERSION PARTNERSHIP.**

**WHEREAS**, the Department of Education (DepEd) has introduced the K to 12 basic education reform program that includes Senior High School (SHS) with the major objective of ensuring that graduates of basic education are ready for employment, entrepreneurship and higher learning;

**WHEREAS**, Jovita Alfaras Rivera National High School (JARNHS) a public institutions which offer General Academic Strand for SHS under the K to 12 curriculum program of the DepEd requires its Senior High School students to undergo work immersion as a prerequisite to graduation;

**WHEREAS**, the Local Government Unit of Bingawan, in its desire to be part of the collaborative effort to further equip Senior High School students with necessary skills in preparation for the opportunities that awaits them is willing to provide venue and accept work immersionist from JARNHS;
