**RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A UNIFIED MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)- FIELD OFFICE VI WITH OFFICE ADDRESS AT M.H. DEL PILAR STREET, MOLO, ILOILO CITY AND HEREIN REPRESENTED BY ITS REGIONAL DIRECTOR, REBECCA P. GEAMALA FOR THE SOCIAL IMPLEMENTATION OF SOCIAL PROTECTION PROGRAMS.**

**WHEREAS**, Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991 provides that “every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;

**WHEREAS**, the Department of Social Welfare and Development, aims to develop and implement social protection programs to address the needs of the poor and the marginalized sectors of the community; thus promoting the general welfare of the populace;

**WHEREAS**, Section 22 (c) of the above-cited code further provides, that “no contract maybe entered into by the local chief executive in behalf of the local government unit without prior authorization by the sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall;


