URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE ILOILO PROVINCIAL GOVERNMENT REPRESENTED BY HONORABLE ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO FOR THE PURCHASE OF ONE (1) UNIT COMPUTER SET AND PRINTER FOR THE UTILIZATION OF THE PAMBAYANG PEDERASYON NG MGA SANGGUNIANG KABATAAN NG BINGAWAN.

WHEREAS, a new set of Sangguniang Kabataan Officials were elected during the Synchronized Barangay and SK elections last May 14, 2018 and the new set of elected officers of the Pambayang Pederasyon ng mga Kabataan held last May 29, 2018;

WHEREAS, it is the desire of the youth to create various programs and activities that will enhance their leadership capabilities, exposure to good governance and develop their general well-being;

WHEREAS, to assist the SK Officials in carrying out the objectives of the youth, it is necessary to provide a faster, efficient and presentable reports, documentations and various communications and other papers related to the Sangguniang Kabataan programs, projects and activities;

WHEREAS, the Pambansang Pederasyon ng mga Sangguniang Kabataan has no source of funds hence the SKMF of the Municipality of Bingawan passed Resolution No. 2018-003 re: "RESOLUTION REQUESTING FOR FINANCIAL ASSISTANCE FROM HON. ARTHUR D. DEFENSOR, SR., PROVINCIAL GOVERNOR, PROVINCE OF ILOILO THE AMOUNT OF PHP 100,000.00 FOR THE PURCHASE OF ONE (1) UNIT COMPUTER SET WITH PRINTER AND PROJECTOR TO BE USED IN THE SANNGUNIANG KABATAAN MUNICIPAL FEDERATION OFFICE OF BINGAWAN, ILOILO;

WHEREAS, however, the Provincial Government can only provide the amount of Fifty Thousand Pesos (Php50, 000.00);

WHEREAS, the Local Unit of Bingawan, through the Pambayang Pederasyon ng mga Sangguniang Kabataan Office shall have the able responsibility and authority to utilize and develop the said financial assistance given by the Iloilo Provincial Government for the general welfare of the youth;

WHEREAS, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”.

NOW THEREFORE:

On motion of Hon. Ramil C. Castroverde, duly seconded by Hon. Nemesio A. Cachite;


RESOLVED AS IT IS HEREBY RESOLVED, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum Of Agreement with the Iloilo Provincial Government represented by Honorable Arthur D. Defensor, Sr., Governor, Province of Iloilo for the purchase of one (1) unit computer set and printer for the utilization of the Pambayang Pederasyon ng mga Sangguniang Kabataan Ng Bingawan.
