**Resolution No. 98 – 2018**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR TO SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRARIAN REFORM REPRESENTED BY ATTY. EUGENE P. FOLLANTE, REGIONAL DIRECTOR OF REGION VI AND THE MUNICIPAL DEVELOPMENT FUND OFFICE OF THE DEPARTMENT OF FINANCE REPRESENTED BY UNDERSECRETARY GIL S. BELTRAN FOR THE IMPLEMENTATION OF THE AGRARIAN REFORM COMMUNITIES PROJECT II – PERFORMANCE-BASED GRANT SYSTEM CAPACITY DEVELOPMENT GRANT (ARCPHII-PBGS CDG).**

**WHEREAS**, the National Government established the Performance Based Grant System (PBGS) for local government units (LGU) to improve the overall LGU performance in governance and to provide monetary incentive to performing LGUs based on an established set of requirements and conditions;

**WHEREAS**, Municipality of Bingawan has expressed its intention to avail of the ARCPHII-PBGS Capacity Development Grant (CDG) under the Department of Agrarian Reform and the Municipal Development Fund Office of the Department of Finance in order to overcome the functional and institutional gaps identified during the assessment of LGU performance;

**WHEREAS**, both parties agree on a common goal of strengthening local performance by funding capacity building support or assistance needed in addressing the gaps or insufficiencies;

**WHEREAS**, the MDFO –Policy Governing Board, as the PBGS Steering Committee, per PGB Resolution No. 24-09-0702018 dated 07 September 2018 approved the Municipality of Bingawan as beneficiary of its Capacity Grant Entitlement for the project “Enhancing Financial Accountability through Effective Internal Control System” amounting to one million six hundred ninety seven thousand eight hundred seventy seven and <sup>49</sup>/<sub>100</sub> pesos (P1,697,877.490);

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

**NOW THEREFORE:**

**On motion of** Hon. Ted Peter P. Plagata, Floor Leader, duly seconded by Hon. Nemesio A. Cachite and Hon. Eduardo A. Dalipe;

**RESOLVED AS IT IS HEREBY RESOLVED**, to authorize Hon. Mark P. Palabrica, Municipal Mayor to Sign for and in Behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with the Department of Agrarian Reform Represented by Atty. Eugene P. Follante, Regional Director of Region VI and the Municipal Development Fund Office of the Department of Finance Represented by Undersecretary Gil S. Beltran for the Implementation of the Agrarian Reform Communities Project II – Performance-Based Grant System Capacity Development Grant (ARCPH-PBGS CDG).
