**Resolution No. 51 – 2018**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF EDUCATION-DISTRICT OF BINGAWAN, AN EDUCATIONAL INSTITUTION WITH BUSINESS ADDRESS AT PLAGA STREET, BARANGAY POBLACION, BINGAWAN, ILOILO, HEREIN REPRESENTED BY ALONA L. CHIVA, Ed.D., DISTRICT SUPERVISOR FOR THE UTILIZATION OF SCHOOLS IN THE DISTRICT OF BINGAWAN AS EVACUATION CENTERS DURING DISASTERS/CALAMITIES.**

**WHEREAS**, the Local Government Unit is mandated by law to extend assistance to victims of disasters;

**WHEREAS**, to ensure the availability of established safe evacuation centers for emergencies and disasters and to ensure that temporary refuge to individual and families potentially at risk or in actual danger are immediately provided;

**WHEREAS**, the Municipal Ordinance No. 208-2015 re: "An Ordinance Prescribing the Guidelines on Pre-emptive and Forced Evacuation Before, During and After natural and, or, man-made disasters and calamities in the Municipality of Bingawan, Province of Iloilo" provides for the designation of public schools as evacuation centers in the different barangays;

**WHEREAS**, Bingawan Central Elementary School, Alabidhan Elementary School, Agba-o Elementary School, Bulabog Elementary School, Guinhulacan Elementary School, Inamyungan Primary School, Malitbog Ilawod Primary School, Don Salvador Hortelano Memorial School, Quinar-upan Elementary School, Quinangyana Elementary School, Bingawan National High School and Jovita Alfaras Rivera National High School were designated as evacuation centers;

**WHEREAS**, the LGU has a five percent (5%) Municipal Disasters Risk Reduction Management Fund, of the amount appropriated for MDRRMF, thirty percent (30%) shall be allocated as Quick Response Fund (QRF) for the relief and recovery programs in order that situation and living conditions of people in communities or areas stricken by disasters, calamities, epidemics, complex emergencies, may be normalized as quickly as possible;

**WHEREAS**, it is to ensure that all evacuation centers are provided with basic needs such as but not limited to food, clothing, domestic items, hygiene;

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;

**NOW THEREFORE:**


**On motion of** Hon. Leovy C. Simora, Floor Leader, duly seconded by Hon. Nemesio A. Cachite;

**RESOLVED, AS IT IS HEREBY RESOLVED**, to authorize Hon. Mark P. Palabrica, Municipal Mayor, Municipality of Bingawan, Iloilo to enter and sign for and in behalf of the Municipality of Bingawan, Iloilo a Memorandum of Agreement with the Department of Education-District of Bingawan, an educational institution with business address at Plaga Street, Barangay Poblacion, Bingawan, Iloilo, herein represented by Alona L. Chiva, Ed.D., District Supervisor for the utilization of schools in the District of Bingawan as Evacuation Centers During disasters/calamities.
