WHEREAS, RULE IX – REGULAR AND SPECIAL SESSIONS, Section 1, of the Internal Rules and Procedures of the Sangguniang Bayan, this municipality provides that xxx *“to bring the sanggunian closer to the people, regular sessions shall be held in barangays at least once every quarter in alphabetical order”* xxx;
