RESOLUTION REQUESTING THE PRESENCE OF ANY REPRESENTATIVE OF THE REGIONAL PROJECT MANAGEMENT OFFICE OF THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) REGIONAL OFFICE 6 - KALAHI CIDSS TO SHED LIGHT ON THE DISAPPROVED OR OBJECTED SUB-PROJECTS OF KALAHI-CIDDS:NCDDP CYCLE 3 (3RD CALL) IN THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, there are four (4) barangays in the Municipality of Bingawan which are the beneficiaries of KALAHI-CIDDS: NCDDP Sub-Projects, namely: Bgy. Bulabog, Bgy. Malitbog Ilaya, Bgy. Ngingi-an and Bgy. Tapacon;

WHEREAS, as per communication from the Regional Project Manager, KC NCDDP DSWD FO6 dated May 16, 2018, the sub-projects for the above-mentioned barangays were issued Objection Letter disapproving said sub-projects;

WHEREAS, the beneficiaries on said barangays are clamoring why such an abrupt disapproval of sub-projects when in fact 80% of the fund was released/downloaded to the barangays concerned and construction material have already been delivered;

NOW THEREFORE:


