URGENT RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR DEFENSOR, JR., CONGRESSMAN 3RD DISTRICT, PROVINCE OF ILOILO IN THE AMOUNT OF SIX MILLION THREE HUNDRED SEVENTY-TWO THOUSAND TWO HUNDRED PESOS (PHP 6,372,200) TO COMPLETE THE OBJECTED SUB-PROJECTS UNDER KALAHY CIDSS NCDDP CYCLE 3.

WHEREAS, the Local Government Unit of Bingawan pursues the objective of alleviating poverty in the localities;

WHEREAS, the Program aims to empower local communities through participation in local governance and involvement in the preparation and implementation of poverty reduction interventions;

WHEREAS, the Municipality of Bingawan is a recipient of KALAHY-CIDSS National Community-Driven Development Program Cycle 3 which was funded by the Asian Development Bank.

WHEREAS, four (4) sub-projects were Objected by the Regional Program Management Office due to lack of time frame allotted to complete the project because the Loan agreement will about to expire at a given time;

NOW THEREFORE:


On motion of Hon. Joy L. Quimba, duly seconded by Hon. Nemesio A. Cachite;
