PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF AGRARIAN REFORM (DAR) ILOILO PROVINCIAL OFFICE REPRESENTED BY ITS OIC-PROVINCIAL AGRARIAN REFORM PROGRAM OFFICER (PARPO) II, SALLY A. PAULIN, BARANGAY LOCAL GOVERNMENT UNIT OF TAPACON REPRESENTED BY ITS BARANGAY CHAIRMAN, HON. JERRY U. MAGBANUA AND THE GUINTAPAGIN AGRARIAN REFORM COOPERATIVE (GUINTAPAGIN ARC) REPRESENTED BY ITS BOARD OF DIRECTOR (BOD) CHAIRPERSON, MAMERTA P. PELAGIO FOR THE IMPLEMENTATION OF THE FARM BUSINESS SCHOOL (FBS).**



**On motion of** Hon. Ted Peter P. Plagata, Deputy Floor Leader, duly seconded by Hon. Nemesio A. Cachite;


