URGENT RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO THROUGH THE EFFORTS OF HON. LORENZ R. DEFENSOR, BOARD MEMBER 3RD DISTRICT, PROVINCE OF ILOILO IN THE AMOUNT OF TWO HUNDRED THOUSAND PESOS (P200,000.00) FOR THE CONSTRUCTION OF STREET LIGHTS IN BRGY. GUINHULACAN, BINGAWAN, ILOILO

WHEREAS, the Municipality of Bingawan pursues the objective of delivering basic services necessary for the promotion of the general welfare of its inhabitants as embodied in Section 16 of R.A. 7160, otherwise known as the Local Government Code of 1991;
