DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO, THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND PESOS (PHP 1,500,000.00) FOR THE REHABILITATION OF FARM TO MARKET ROAD AT BARANGAY NGINGI-AN TO SITIO SINAMUNGAN, BARANGAY BULABOG, BINGAWAN, ILOILO.**

**WHEREAS**, the residents of Barangay Ngingi-an and Sitio Sinamungan of Brgy. Bulabog wanted to have an easy road access to transport farm produce to the market;




