**Resolution No. 78 - 2018**

**RESOLUTION THANKING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) FOR TAKING ACTION ON THE REQUEST OF THIS MUNICIPALITY TO CONVERT THE BARANGAY ROAD IN BRGY. SWITCH, TAPAZ, CAPIZ INTO A NATIONAL ROAD.**

**WHEREAS**, Vice Mayor Matt P. Palabrica, Ph.D. rendered a privilege speech expressing and presenting the status of the said barangay road, its impact to local and national economy and contribution to peace, order and security;

**WHEREAS**, the Municipality of Bingawan, Iloilo passed a Resolution No. 14-2018 requesting for the conversion of Bgy. Switch road into a National Road;

**WHEREAS**, the Sangguniang Panlalawigan of the Province of Iloilo passed Resolution No. 2018-356, requesting the same;

**WHEREAS**, the Department of Public Works and Highways Central Office through its 2<sup>nd</sup> District Engineering Office, Dumalag, Capiz made an immediate survey for concreting of Bgy. Switch road, Tapaz, Capiz, with the length of five hundred (500) linear meters connecting two (2) national roads of the Municipality of Bingawan, Province Iloilo and the Municipality of Tapaz, Capiz, as the barangay road was later found out to have been declared a National Secondary Road by virtue of Department Order No. 138, Series of 1978 of the Ministry of Public Highways dated October 6, 1978;

**WHEREAS**, the accessibility of the Switch barangay road would uplift socio-economic interactions not only between the above-cited municipalities but of the two neighboring provinces as well;
