**Resolution No. 79 - 2018**

**URGENT RESOLUTION REQUESTING THE DEPARTMENT OF AGRICULTURE TO ALLOCATE FUND IN THE AMOUNT OF EIGHT MILLION TWO HUNDRED NINE THOUSAND ONE HUNDRED SIXTY SEVEN PESOS & 77/100 (Php 8,209,167.77) FOR THE CONCRETING OF 750 LN.M. ACCESS ROAD WITH 260 LN.M. STONE MASONRY FARM TO MARKET ROAD LOCATED AT BRGY. MALITBOG ILAWOD, BINGAWAN, ILOILO.**

**WHEREAS**, the Municipality of Bingawan is a 5<sup>th</sup> Class Municipality and is considered an agricultural community with more than 3,000 hectares devoted to farming;

**WHEREAS**, Brgy. Malitbog Ilawod is one of the major producers of agricultural products in the Municipality covering an agricultural area of 260.4208 hectares;

**WHEREAS**, a large tract of land of Barangay Malitbog Ilawod is dedicated to planting of different varieties of vegetables and root crops and raising of livestock and poultry in the Municipality of Bingawan due to the presence of the MAGMAINAM UPLAND FARMERS ASSOCIATION (MUFA) that contributes to the social and economic growth of the community;

**WHEREAS**, an existing farm-to-market road particularly in Zone 1 of Brgy. Malitbog Ilawod serves as the primary access of farmers to the market;

**WHEREAS**, the said road is currently in poor condition making it difficult for farmers to transport their products especially during rainy season;

**WHEREAS**, farm to market road are among the contributing factors in ensuring food and economic security and sustainability;

**WHEREAS**, Brgy. Malitbog Ilawod expressed their willingness to accept the Responsibility of the Operation and Maintenance of the said road if materialized.


**NOW THEREFORE:**

Malitbog Ilawod, Bingawan, Iloilo.
