URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, TO ACCEPT AND SIGN IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A DEED OF DONATION EXECUTED BY ANGELES F. PINEDA OF A LOT IN FAVOR OF THE MUNICIPALITY OF BINGAWAN, ILOILO.

WHEREAS, the Donor is the owner in fee simple of a certain real property situated in Barangay Tapacon, Municipality of Bingawan, Province of Iloilo, Island of Panay and more particularly described in a Transfer Certificate of Title No. T-145, 925 of the Registry of Deeds for the Province of Iloilo, Republic of the Philippines;

WHEREAS, a parcel of land (Lot 7142-C, PSD-063010-025056, being a portion of Lot 7142, Cad. 186, Calinog Cad.), situated in the Barangay of Tapacon, Municipality of Bingawan, Province of Iloilo, Island of Panay. Containing an area of Twenty Six Thousand Two Hundred Ninety Seven (26, 297) square meters, more or less;

WHEREAS, the said Lot is the present location of the YMCA Building in Brgy. Tapacon, Bingawan, Iloilo;

WHEREAS, that for and in consideration of the love and affection which the DONOR has for the people and inhabitants of the DONEE, the said DONOR, transfers and conveys, by way of DONATION, unto the said DONEE, a portion of the above-described real property, specifically Lot 7142-C-1 containing an area of FIVE HUNDRED FORTY SEVEN (547) SQUARE MATERS, more or less, with all the buildings and improvements thereon, free from all liens and encumbrances.
