**Resolution No. 81 - 2018**

**URGENT RESOLUTION AUTHORIZING HON. MARK P. PALABRICA, MUNICIPAL MAYOR, MUNICIPALITY OF BINGAWAN, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF BINGAWAN, ILOILO A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH REPRESENTED BY FRANCISCO T. DUQUE III, MD, MSc, SECRETARY OF HEALTH FOR THE PROVISION OF 1 UNIT AMBULANCE FOR THE MUNICIPAL HEALTH OFFICE OF BINGAWAN, ILOILO.**

**WHEREAS**, the State recognizes its mandate to provide equitable and accessible quality healthcare for all Filipinos;

**WHEREAS**, “*Boosting Universal Health Care via FOURmula One for Health Plus (or FI+)*” envisions quality health care to be more accessible to the poor and vulnerable population by ensuring the availability of functional health care facilities;

**WHEREAS**, the Health Facilities Enhancement Program (HFEP) aims to improve the delivery of health services through the upgrading of health facilities and provision of medical equipment in order to make them more responsive to the health needs of the population;

**WHEREAS**, the Municipality of Bingawan is a recipient of 1 unit Ambulance from Department of Health (DOH)- Health Facilities Enhancement Program (HFEP);

**WHEREAS**, the provision of ambulance shall contribute to the functionality of the health system and the delivery quality health care;

**WHEREAS**, pursuant to Section 22 (c) of R.A. 7160, otherwise known as the Local Government Code of 1991, "no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned. A legible copy of such contract shall be posted at a conspicuous place in the municipal hall".


**NOW THEREFORE:**
