RESOLUTION DESIGNATING HONORABLE RAMIL C. CASTROVERDE AS THE NEW MEMBER OF THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO AS VACATED BY FORMER SB MEMBER LEOVY C. SIMORA.

WHEREAS, pursuant to Article 187 of the Rules and Regulations Implementing the Local Government Code of 1991, "there should be established in the local government unit concerned a People's Law Enforcement Board (PLEB) pursuant to the pertinent provisions of R.A. 6975" (as amended);

WHEREAS, in deference to Section 43 (b) (1) of R. A. 6975 as amended, the (municipal) People's Law Enforcement Board (PLEB) shall have a representative from the Sangguniang Bayan chosen from among themselves;

WHEREAS, the Sangguniang Bayan of the Municipality of Bingawan, Province of Iloilo, has chosen Honorable Ramil C. Castroverde as the new PLEB representative as vacated by former SB Member Leovy C. Simora;

NOW THEREFORE:

ON MOTION of Hon. Ted Peter P. Plagata, Deputy Floor Leader, duly seconded by Hon. Nemesio A. Cachite;

RESOLVED AS IT IS HEREBY RESOLVED, to reorganize the officers and regular or standing committees of the 13th Sanggunian of the Municipality of Bingawan, Province of Iloilo;

RESOLVED FURTHER, that all mandatory positions in the Local Special Bodies of the LGU based on R.A. 7160 be replaced as vacated by the two said former SB Members;

RESOLVED FURTHER, to request the Municipal Mayor to replace membership in the Working Committees of the LGU vacated by the two said former SB Members;
