URGENT RESOLUTION URGING THE DEPARTMENT OF BUDGET AND MANAGEMENT (DBM), THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT (DILG) AND THE COMMISSION ON AUDIT (COA) FOR THE ISSUANCE OF IMPLEMENTING RULES AND REGULATIONS (IRR) FOR THE SANGGUNIANG KABATAAN FUNDS.

WHEREAS, the State recognizes the vital role of the youth in nation-building and thus, promotes and protects their physical, moral spiritual, intellectual and social well-being, inculcates in them patriotism, nationalism, and other desirable values, and encourages their involvement in public and civic affairs;

WHEREAS, a new set of Sangguniang Kabataan Officials were elected during the Synchronized Barangay and SK elections last May 14, 2018;

WHEREAS, Section 20 of the RA 10742, the Sangguniang Kabataan is entitled of the 10% of the general fund of the Barangay to carry out the identified activities in an organization's plan;

WHEREAS, a budget is necessary to carry out the program for the youth in the Barangay in accordance with the Annual Barangay Youth Investment Plan (ABYIP);

WHEREAS, the said Committee on Youth and Sports has several sports and youth development programs that will enable the youth to discover their potentials and develop their skills, but in order to bring success to the programs, a budgetary requirement with fund is hereby needed;

WHEREAS, to provide financial assistance for the planned event, there is a need for the issuance of Implementing Rules and Regulations (IRR) for the release of SK Fund;
