URGENT RESOLUTION REQUESTING FINANCIAL ASSISTANCE FROM HON. ARTHUR D. DEFENSOR, SR., GOVERNOR, PROVINCE OF ILOILO THE AMOUNT OF TWO HUNDRED FIFTY THOUSAND PESOS (P250,000.00) FOR THE IMPROVEMENT OF MUNICIPAL (ANNEX) BUILDING OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO.

WHEREAS, the Municipality of Bingawan pursues the objective of delivering basic services necessary for the promotion of the general welfare of its inhabitants as embodied in Section 16 of R.A. 7160, otherwise known as the Local Government Code of 781991;

WHEREAS, the Municipality of Bingawan has a new two-storey Municipal Annex Building that serves as Municipal Social Welfare and Development Office;

WHEREAS, the Municipal Social Welfare and Development Office is one of the most visited offices since it extends services to the senior citizens; persons with disability; solo parents; day care; AICS (Aid to Individual in Crisis Situation) for burial, medical and emergency shelter assistance; comprehensive local integration program; children in conflict of the law; KALAH!; 4Ps and SLP;

WHEREAS, there is a need to improve the new annex building through installation of air-conditioning units in order to better serve their clients;

WHEREAS, the Municipality of Bingawan, a 5th income class LGU has no sufficient funds to finance the said improvement;

NOW THEREFORE:

On motion of Ted Peter P. Plagata, Floor Leader, duly seconded by Hon. Nemesio A. Cachite, Hon. Eduardo A. Dalipe and Hon. Ramil P. Artuz;

RESOLVED AS IT IS HEREBY RESOLVED, to request financial assistance from Hon. Arthur D. Defensor, Sr., Governor, Province of Iloilo the amount of Two Hundred Fifty Thousand Pesos (P250,000.00) for the improvement of Municipal (Annex) Building of the Municipality of Bingawan, Province of Iloilo.


