URGENT RESOLUTION ACCEPTING THE RESIGNATION OF HONORABLE LEOVY CASTRONUEVO SIMORA AS SANGGUNIANG BAYAN MEMBER OF THE MUNICIPALITY OF BINGAWAN, PROVINCE OF ILOILO, AND DECLARING THE POSITION VACANT.

WHEREAS, SB Member Leovy C. Simora sent a communication to the Office of the Vice Mayor, Honorable Matt P. Palabrica dated August 15, 2018, tendering his resignation as Sangguniang Bayan Member effective August 30, 2018; said communication was received by the Office of the Vice Mayor last August 28, 2018;

WHEREAS, pursuant to the pertinent provisions of R.A. 7160, otherwise known as the Local Government Code of 1991, resignations of elective local officials shall be deemed effective only upon acceptance of the following authorities: "by the sanggunian concerned in case of sangguniang bayan members";

WHEREAS, in deference further to the codal provisions, irrevocable resignations by sanggunian members shall be deemed accepted upon presentation before an open session of the sanggunian concerned and duly entered into its records;

WHEREAS, as provided finally, a permanent vacancy arises when an elective local official XXX voluntarily resigns XXX;
