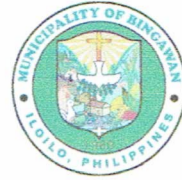

**Resolution No. 95 – 2018**

**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, HON. MARK P. PALABRICA, AND THE MUNICIPAL HEALTH OFFICER, DR. DIEGO ALAN E. ESTAMPADOR TO OPEN TRUST FUND ACCOUNTS AT LANDBANK OF THE PHILIPPINES (LBP)-PASSI BRANCH, PASSI CITY FOR PROFESSIONAL FEE AND HEALTH CARE UTILITIES IN CONNECTION WITH THE MANDATORY IMPLEMENTATION OF AUTO CREDIT PAYMENT SCHEME (ACPS) OF PHILHEALTH REIMBURSEMENTS, ALSO AS SIGNATORIES OF SAID ACCOUNTS.**

**WHEREAS**, pursuant to PhilHealth Circular 2017-0020 on nationwide implementation OF ACPS, all accredited Health Care Institutions (HCIs) are required to be ACPS compliant for purposes of claims reimbursements;

**WHEREAS**, all Health Care Institutions (HCIs) are required to open deposit accounts with the local banks authorized to do banking business in the Philippines under the supervision and regulation of the Bangko Sentral ng Pilipinas, for the Philhealth auto-credit payment facility;

**WHEREAS**, Section 22 (c) of RA 7160 provides that “no contract may be entered into by the local chief executive in behalf of the local government unit without prior authorization by the Sanggunian concerned”;


**NOW THEREFORE:**

Estampador to open Trust Fund Accounts at Landbank of the Philippines (LBP)-Passi Branch, Passi City for Professional Fee and Health Care Utilities in connection with the mandatory implementation of Auto Credit Payment Scheme (ACPS) of Philhealth reimbursements, also as signatories of said accounts.


